CHAPTER III.—LEGISLATIVE POWERS OF THE PRESIDENT

23. Power of President to promulgate Ordinances during recess of Parliament.—(1) If at any time, except when both Houses of Parliament are in session, the President is satisfied that circumstances exist which render it necessary for him to take immediate action, he may promulgate such Ordinances as the circumstances appear to him to require.

(2) An Ordinance promulgated under this article shall have the same force and effect as an Act of Parliament, but every such Ordinance—

shall be laid before both Houses of Parliament and shall cease to operate at the expiration of six weeks from the reassembly of Parliament, or, if before the expiration of that period resolutions disapproving it are passed by both Houses, upon the passing of the second of those resolutions; and

) may be withdrawn at any time by the President.

Suppose Rs. 100 bond (this is called issue price or Face Value) is issued @ interest rate 10% (which means that interest in the market is around 10%). Now if interest rate in the market decreases (the interest rate is decreasing in the market but the bond which has been issued @10% interest rate. This interest rate is fixed and it will never change) then the new bonds which will be issued will be issued at less interest rate (say 8%).

Now if you want to purchase previously issued bond of Rs. 100 face value, the holder of the bond will not give you in Rs. 100, rather he will ask for more rupees, i.e., the price of the previously issued bond will increase and suppose you purchase this bond in Rs. 125 then for your annual RETURN will be = (Rs. 10/Rs. 125)*100 = 8%. This 8% is yield.

So, to conclude, if interest rate in market decreases, price of bond increases and return (yield) on that bond decreases.

Also, he did not make a direct attack on the caste system, rather he threw open his order to all people of any caste.

The first human statues worshiped in India were those of the Buddha. The devotees of the religion portrayed the various events in the life of Buddha in stone.

When Buddha started Sangha, the Buddhists predominantly consisted of men. Women did not participate in the early beginnings of Sangha, therefore, many women wanted to join the Sangha and yearned for equality. However, they could not get easy access as there was no tradition of assimilation. But later it happened...Don't get misguided by nay notes. Women were part of it.

Example: In the Therigatha (The Songs of the Women Elders)

For example, Sumangala, Bhikkhuni says:

"O Woman well set free! How free I am,



The research shows that seagrasses convert organic carbon into large amounts of sugar during photosynthesis, mainly sucrose. Globally, seagrasses have produced between 0.6 and 1.3 million tonnes of these sugars.

Like terrestrial plants, seagrass also photosynthesize and manufacture their own food and release oxygen.

Third statement is correct.

Seagrasses reproduce through both sexual and asexual methods. The pollen from the flower of the male plant is transferred to the ovary of the female flower through the sexual reproduction method. **This is known as submarine pollination**. Most species undergo this process and complete their life cycle underwater.

Seagrasses can also reproduce asexually by branching off at their rhizomes (modified subterranean plant stem that sends out roots and shoots from its nodes). **Because of this character, they can recover after being cut by grazers like dugongs or disturbed by storms.**

Second statement is correct.

Seagrasses occur all along the coastal areas of India. They are abundant in the Palk Strait and Gulf of Mannar in Tamil Nadu.

Though seagrasses inhabit all types of substratas (layers) from mud to rock, the lush green seagrass beds are found extensively in muddy and sandy substratas.

Law Commission of India is a **non-statutory body and is constituted by a notification of the Government of India**, Ministry of Law & Justice, Department of Legal Affairs with a definite term of reference to carry out research in the field of law and the Commission makes recommendations to the Government (in the form of Reports) as per its terms of reference.

The Central Government **established the First Law Commission in 1955** with the then Attorney-General of India, Mr. M. C. Setalvad, as its chairman. Since then, twenty-two Law Commissions have been appointed, each with a **three-year term** and with a definite term of reference.

Odisha has a rich depository of sal seeds accounting for 25 per cent of the country's **production**, which played a significant role in the economics of the tribal people in the state.

Around 40 per cent of the total tribal populations here are engaged in collecting and processing the seeds to eke out a living. Other major sal seeds producing states include Bihar, Chhattisgarh, Madhya Pradesh, and Jharkhand.

The sal oil can be used for manufacture food and non-food industries. The sal oil can be used as cooking oil and substitute for cocoa butter in chocolate industry after refining process. The sal seed and its oil are in underutilized stage because of its low price and lack of technology for its processing activities.



A decrease in crude oil prices would **reduce the import bill** of India as India imports about 70 per cent of its crude requirements. This would **reduce the demand for foreign currency**, which in turn would lead to **an increase in the value of the rupee**. **So, Statement (3) is correct**.

THE FINANCE COMMISSION (MISCELLANEOUS PROVISIONS) ACT, 1951

ACT No. 33 of 1951

[16th May, 1951.]

An Act to determine the qualifications requisite for appointment as members of the Finance Commission and the manner in which they shall be selected, and to prescribe their powers.

6. Term of office of members and eligibility for reappointment.—Every member of the Commission shall hold office for such period as may be specified in the order of the President appointing him, but shall be eligible for reappointment:

Provided that he may, by letter addressed to the President, resign his office.

Procedure and powers of the Commission.—(1) The Commission shall determine their procedure and in the performance of their functions shall have all the powers of a civil court under the Code of Civil Procedure, 1908 (5 of 1908), while trying a suit in respect of the following matters, namely:—


There are two types of radiations:

- a. Ionizing radiations
- b. Non-ionizing radiations

These radiations have high penetration power and breaks into macro molecules in the body. Examples: **X-Rays**, Gamma rays, Atomic Plants, etc.

Non-ionizing radiation is the term given to radiation in the part of the electromagnetic spectrum where there is insufficient energy to cause ionization.

It includes electric and magnetic fields, radio waves, microwaves, infrared, ultraviolet, and visible radiation. WIFI devices, Telecom Towers will come under this.



Remember this also:

Longer wavelength, lower frequency waves (heat and radio) have less energy than shorter wavelength, higher frequency waves (X and gamma rays).





Thus, simultaneous efforts were started in early 1970s to increase productivity and production of other crops and livestock especially dairy and poultry. HISTORY OF METEOROLOGICAL SERVICES IN INDIA

The beginnings of meteorology in India can be traced to ancient times. Early philosophical writings of the 3000 B.C. era, such as the Upanishadas, contain serious discussion about the processes of cloud formation and rain and the seasonal cycles caused by the movement of earth round the sun Varahamihira's classical work, the Brihatsamhita, written around 500 A.D., provides a clear evidence that a deep knowledge of atmospheric processes existed even in those times. It was understood that rains come from the sun (Adityat Jayate Vrishti) and that good rainfall in the rainy season was the key to bountiful agriculture and food for the people. Kautilya's Arthashastra contains records of scientific measurements of rainfall and its application to the country's revenue and relief work. Kalidasa in his epic, 'Meghdoot', written around the seventh century, even mentions the date of onset of the monsoon over central India and traces the path of the monsoon clouds!

Meteorology, as we perceive it now, may be said to have had its firm scientific foundation in the 17th century after the invention of the thermometer and the barometer and the formulation of laws governing the behaviour of atmospheric gases. It was in 1636 that Halley, a British scientist, published his treatise on the Indian summer monsoon, which he attributed to a seasonal reversal of winds due to the differential heating of the Asian land mass and the Indian Ocean.

India is fortunate to have some of the oldest meteorological observatories of the world. The British East India Company established several such stations, for example, those at Calcutta in 1785 and Madras (now Chennal) in 1796 for studying the weather and climate of India. The Asiatic Society of Bengal founded in 1784 at Calcutta, and in 1804 at Bombay (now Mumbal), promoted scientific studies in meteorology in India Captain Harry Piddington at Calcutta published 40 papers during 1835-1855 in the Journal of the Asiatic Society dealing with tropical storms and coined the word "cyclone", meaning the coil of a snake in 1842 he published his monumental work on the "Laws of the Storms". In the first half of the 19th century, several observatories began functioning in India under the provincial governments.

Gharials are top predators and keystone species in running freshwater systems. They play a crucial role in bringing nutrients from the bottom of the riverbed to the surface, thus increasing fish populations and helping maintain the aquatic ecosystem. "Of the three crocodilian species, the gharial is the most efficient fish catcher because of its unique snout. It derives its name from "ghara", the Indian word for pot, because of a bulbous knob present at the end of its snout," says Akash Deep Badhawan, a divisional forest officer at KWS.


The **Indian Ocean Dipole or IOD** is caused by alternate warming and cooling in the Indian Ocean along the Equator from west to east, much like the ENSO.

The Equatorial Indian Ocean Oscillation (EQUINOO) is thought to arise as an effect of the IOD and refers to increased and decreased cloud formation between the western and eastern equatorial Indian Ocean.

Although the IOD was discovered only in 1999, and the EQUINOO in 2002, both have been recognised as important modulators of the Indian summer monsoon. Positive IOD and EQUINOO events are associated with more rainfall as these events increase moisture transport from the southeastern parts of the Indian Ocean.

The **Atlantic SST variability affects** the Indian summer monsoon in the same way that the ENSO does. A **warming of the surface of the Atlantic Ocean weakens the monsoon, just as cooling of the ocean's surface has the opposite effect**. The effects of this phenomenon, also known as the Atlantic Niño, on the Indian summer monsoon, is thought to be mediated through perturbations in the jet streams above India.

The Mascarene High is a semi-permanent high-pressure zone in the south Indian Ocean, about 4,000 km from India, near the Mascarene Islands. The Mascarene High begins developing in mid-April and is a major factor in driving the circulation between the northern and southern hemispheres that powers the summer monsoon winds towards the Indian subcontinent from the Indian Ocean.



Both systems are independent of each other and to make the certification system affordable and accessible without the need for third-party certification agencies, PGS-India was implemented. This is a farmer group-centric certification system for local and domestic markets.

NPOP was launched during 2001 by the Government of India under Ministry of Commerce and Industry. The NPOP not only provides the institutional framework for accreditation of certification agencies and operationalization of certification programme through its accredited Certification Bodies (CBs) but also ensures that the system effectively works and is monitored on regular basis.

Under PGS-India programme, Government is implementing Participatory Guarantee System of India (PGS-India) as a quality assurance initiative for certification of organic produce that is locally relevant, emphasizing the participation of stakeholders, including producers / farmers and consumers and operate outside the frame of third-party certification.

In the operation of PGS-India, stakeholders (including farmers/ producers) are involved in decision making and essential decisions about the operation of the PGS-India certification itself by assessing, inspecting, and verifying the production practices of each other and collectively declare produce as organic.

Before Independence, an Antiquities (Export Control) Act had been passed in April 1947 to ensure that "no antiquity could be exported without license." In 1958, The Ancient Monuments and Archaeological Sites and Remains Act was enacted. Then in 1971, Parliament saw an uproar over the theft of a bronze idol from Chamba and some important sandstone idols from other places.

This, along with the UNESCO convention (mentioned below), prompted the government to enact The Antiquities and Art Treasures Act, 1972 (AATA), implemented from April 1, 1976.

An Act to regulate the export trade in antiquities and art treasures, to provide for the prevention of smuggling of, and fraudulent dealings in, antiquities, to provide for the compulsory acquisition of antiquities and art treasures for preservation in public places and to provide for certain other matters connected therewith or incidental or ancillary thereto.

BE it enacted by Parliament in the Twenty-third Year of the Republic of India as follows:—

1. Short title, extent and commencement.—(1) This Act may be called the Antiquities and Art Treasures Act, 1972.

The 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property urges States Parties to take measures to prohibit and prevent the illicit trafficking of cultural property. It provides a common framework for the States Parties on the measures to be taken to prohibit and prevent the import, export and transfer of cultural property.

Extent of liability.- When in the course of working a railway, an accident occurs, being either a collision between trains of which one is a train carrying passengers or the derailment of or other accident to a train or any part of a train carrying passengers, then whether or not there has been any wrongful act, neglect or default on the part of the railway administration such as would entitle a passenger who has been injured or has suffered a loss to maintain an action and recover damages in respect thereof, the railway administration shall, notwithstanding anything contained in any other law, be liable to pay compensation to such extent as may be prescribed and to that extent only for loss occasioned by the death of a passenger dying as a result of such accident, and for personal injury and loss, destruction, damage or deterioration of goods owned by the passenger and accompanying him in his compartment or on the train, sustained as a result of such accident.

Since 1994, the Act has also made the railway administration liable to pay compensation for loss of life or injury to bonafide rail passengers, who become victims of untoward incidents such as terrorist acts, violent attacks, robberies, dacoity, rioting, shoot-out or arson by any persons in or on any train carrying passengers, waiting hall, cloakroom, reservation or booking office, platform, any place within the precincts of a railway station or the accidental falling of any passenger from a train carrying passengers.






Marine Environment

INTRODUCTION

India has been endowed with a vast marine ecosystem and bio-diversity, which sustains a large number of species and the coastal populace is dependent on the resources from this marine eco-system. The need for protection of this eco-system has been acknowledged worldwide and UNCLOS 1982 prescribes the responsibility on the Coastal States in preserving and protecting the marine environment and associated resources. The Maritime Zones of India Act 1976, enables the Government to take measures for protection of the marine environment. The Coast Guard Act 1978 states that the preservation and protection of marine environment and control of marine pollution is the function of the Indian Coast Guard. The ICG has been accordingly nominated in 1986 as the Central Coordinating Authority for oil-spill response in the Maritime Zones of India and Coast Guard officers have been empowered under the Merchant Shipping Act 1958, for taking necessary actions against polluters.

Types of coal found in India

Bituminous: It is a medium grade of coal having high heating capacity. It is the most commonly used type of coal for electricity generation in India. Most of bituminous coal is found in Jharkhand, Odisha, West Bengal, Chhattisgarh, and Madhya Pradesh.

Subbituminous: It is black in colour, dull (not shiny) and has a higher heating value than lignite.



The Brihadeshvara Hindu Temple

The sacred monument of Brihadeshvara Temple of Tanjore, Tamilnadu, south India (1010 AD) is listed on the UNESCO's World Heritage Sites (1987) as part of the three Chola temples of Southern India. They represent an outstanding creative achievement in the architectural conception of the pure form of the Dravida temples. This style, originally known as Dravidadesha style, was practiced during several dynasties only in the state of Tamilnadu in South India. Standards / Norms for Recognition of Elephant Rehabilitation/Rescue Centres under Section 42 of the Wildlife Protection Act, 1972

An Expert Group, chaired by Inspector General of Forests (Project Elephant) was constituted on 30th April, 2015 by the Central Zoo Authority to "Develop Standards / Norms for Recognition of Elephant Rehabilitation/Rescue Centres (ERCs)" (copy enclosed). This decision was necessitated in view of large numbers of complaints regarding abuse of captive elephants from elephant lovers/animal right activists, both within and outside the country. The Expert Group met three times on 17th July, 2015; 9th September, 2015 and 20th January, 2016 and a draft report, developed in its last meeting, was circulated to all members vide email dated 4.2.2016 and the report was modified in view of comments received from various quarters.

Captive Elephant Welfare Committee (District Level), duly notified by the State Governments will be authorized to periodically inspect all ERCs and complaints relating to captive elephants and submit their report to the Chief Wildlife Warden of the State/UTs concerned for certification of norms by concerned ERCs.

Important guidelines:

- 1. ERCs should be located, preferably near the forest areas with access to water body/streams.
- ERCs should be designed for a minimum of 5 elephants and maximum of 50 elephants.
- As a thumb rule, the minimum area for ERCs should be 0.2 hectares/elephant.
 - 4. Perimeter of ERCs should be fenced with an elephant proof barrier. Eg. Solar power fence, elephant proof trenches and/or walls

3 Dimethyl ether (DME) and its synthesis

DME is a clean burning, synthetic fuel, completely soot-less. It is a substitute for diesel fuel or liquefied petroleum gas (LPG). When used instead of diesel fuel, it reduces NOx emissions by 90%, and offers a high cetane number. It can also be reformed into a hydrogen fuel for fuel cells. It is produced from natural gas, but it can also be produced from other sources like biomass and coal. DME is produced by an in-direct method as well as in a one-step, direct process.

India's first 100% Dimethyl Ether (DME) -fuelled tractor/ vehicle for on- and off-road applications has been developed.

To bring the country up to speed in renewable energy sector, researchers at IIT Kanpur developed a **100% DME-fuelled engine with a mechanical fuel injection system**. It exhibited **higher thermal efficiency and lower emissions than the baseline diesel engine.**







Suppose there is only one factory (capital good) in a country, which is worth Rs. one lakhs and is producing consumption goods worth Rs. 700 and capital goods worth Rs. 300 in a particular year (say 2019-20) in an economy. This means that the GDP in 2019-20 will be Rs. 1000 (which is the total production of both consumption and capital goods) and the gross investment in the economy will be Rs. 300 or (Rs 300/Rs1000) 30%, as investment is measured as the percentage of output which consists of capital goods.



Depreciation is also defined as consumption of physical capital. In the above example Rupees one lakh worth of capital goods produce Rs. 700 consumption goods and Rs. 300 capital goods, but during this production process suppose there is wear and tear of Rs. 50 in the factory. This implies that to produce Rs. 700 of consumption goods and Rs. 300 of capital goods there is a loss of Rs. 50 of capital goods in the economy i.e. net production of capital goods (investment) in the economy is Rs. 300 minus Rs. 50. Net Investment = Gross Investment - **Depreciation = Rs. 300 - Rs. 50 = Rs. 250**



India had adopted the National Agroforestry Policy in 2014. It defined agroforestry as a land-use system which integrates trees and shrubs on farmlands and rural landscapes to enhance productivity, profitability, diversity and ecosystem sustainability. With an appropriate mix of species, agroforestry enables agricultural land to withstand extreme weather events such as floods and droughts and enhance farmers' income.



The National Forest Policy (1988) was aimed at forest coverage of 33 per cent of the total geographical area; as of now, only around 22 per cent of the area is under forest cover. There is little scope for increasing the area under forests; hence, that gap can be filled by expanding the area under agroforestry.

Some of the frequently grown tree species in agroforestry are neem, teak, eucalyptus, poplar, bamboo, amla, drumstick, banyan, peepal and acacia. These species are useful for medicinal purposes and repelling insects; they also provide timber and plywood.

Third statement is correct:

Agrolorestry plays a significant role in mitigating climate change and increasing land lertility and productivity by carbon fixation. Trees absorb carbon dioxide through photosynthesis and act as carbon sinks. Agroforestry contribute to carbon sequestration and can offset greenhouse gas emissions. The atmospheric carbon fixation of agroforestry is on an average more than 15 tonnes of carbon/hectare/year, while cropping systems such as rice-wheat fix only less than 0.3 tonnes. Hence, carbon fixation can be achieved by shifting from lower biomass land use (e.g. grasslands) to tree-based systems such as agroforestry. Carbon sequestration in Indian agroforests varies from 19.56 tonnes/hectare/year in Uttar Pradesh to 23.46-47.36 tonnes in tree-bearing arid agro-ecosystems of Rajasthan.



What is Soil Health Card (SHC) scheme?

It is a Government of India's scheme promoted by the Department of Agriculture & Co-operation under the Ministry of Agriculture. It will be implemented through the Department of Agriculture of all the State and Union Territory Governments. A SHC is meant to give each farmer soil nutrient status of his holding and advice him on the dosage of fertilizers and also the needed soil amendments, that he should apply to maintain soil health in the long run.

What is a Soil Health Card?

SHC is a printed report that a farmer will be handed over for each of his holdings. It will contain the status of his soil with respect to 12 parameters, namely N,P,K (Macro-nutrients); S (Secondary-nutrient); Zn, Fe, Cu, Mn, Bo (Micro - nutrients); and pH, EC, OC (Physical parameters). 

Tribhangi position

The torso movement is very important and is a unique feature of the Odissi style. With the lower half of the body remaining static, the torso moves from one side to the other along the axis passing through the centre of the upper half of the body.

For centuries **maharis**were the chief repositories of this dance. The maharis, who were originally temple dancers came to be employed in royal courts which resulted in the degeneration of the art form.

Around this time, a class of boys called **gotipuas**were trained in the art, they danced in the temples and also for general entertainment. Many of today's gurus of this style belong to the gotipua tradition.

An Odissi orchestra essentially consists of a pakhawaj player (usually the Guru himself), a singer, a flutist, a sitar or violin player and a manjira player.

Spurred by public concern, the international community was quick to respond. The successful Montreal Protocol, which has so far reduced some hundred ozone-depleting substances by a total of 98 per cent, was agreed in 1987 within four years of the discovery of the ozone hole over Antarctica. Negotiations on the UN's Framework Convention on Climate Change, Convention of Biological Diversity, and Convention to Combat Desertification followed, and these were agreed in 1992. But the world also needed an international financial mechanism to tackle global environmental problems and help implement the new conventions.

In September 1989 France proposed, through its Finance Minister, that the World Bank be provided with additional resources to fund environmental projects, offering to support it with a contribution of 900 million French francs over a three year period. Its proposal, to the Bank's Development Committee, was quickly seconded by Germany. And little more than a year later - in November 1990 – after the Bank had developed the proposal, with extensive consultations and negotiations - 27 countries, including nine developing ones, agreed to set up a pilot Global Environment Facility (GEF), with about \$1 billion for its first three years.

So, we can it is a **FINANCIAL MECHANISM for five major international environmental conventions**: the Minamata Convention on Mercury, the Stockholm Convention on Persistent Organic Pollutants (POPs), the United Nations Convention on Biological Diversity (UNCBD), the United Nations Convention to Combat Desertification (UNCCD) and the United Nations Framework Convention on Climate Change (UNFCCC).

India and Global Environment Facility (GEF)

The Global Environment Facility (GEF) is a financial mechanism that provides grants to developing countries for projects that benefit the global environment and promote sustainable livelihoods in local communities. GEF projects address six designated focal areas: Biodiversity, Climate Change, International Waters, Ozone Depletion, Land Degradation and Persistent Organic Pollutants.

India has formed a permanent Constituency in the Executive Council of the GEF together with Bangladesh, Sri Lanka, Bhutan, Nepal and Maldives. The Council Meetings are held semi-annually or as frequently necessary. At each meeting, the Council elects a Chairperson from among its members for the duration of that meeting. India's Executive Director in the World Bank represents the GEF Council from our Constituency.



Valuable metals are commonly bound up in solid minerals. Some microbes can <u>oxidize</u> those metals, allowing them to dissolve in water. This is the basic process behind most biomining, which is used for metals that can be more easily recovered when dissolved than from the solid rocks. A different biomining technique, for metals which are not dissolved by the microbes, uses microbes to break down the surrounding minerals, making it easier to recover the metal of interest directly from the remaining rock.

What metals are currently biomined?

Most current biomining operations target valuable metals like copper, uranium, nickel, and gold that are commonly found in sulfidic (sulfur-bearing) minerals. Microbes are especially good at oxidizing sulfidic minerals, converting metals like iron and copper into forms that can dissolve more easily. Other metals, like gold, are not directly dissolved by this microbial process, but are made more accessible to traditional mining techniques because the minerals surrounding these metals are dissolved and removed by microbial processes. When the metal of interest is directly dissolved, the biomining process is called "bioleaching," and when the metal of interest is made more accessible or "enriched" in the material left behind, it is called "biooxidation." Both processes involve microbial reactions that can happen anywhere the microbes, rocks, and necessary nutrients, like oxygen, occur together.



However, in the same case, it was further propounded that through the route of Article 368, the basic structure of the Constitution cannot be altered. **Fourth statement is correct.**

The National Commission on Agriculture, Government of India, first used the term 'social forestry' in 1976. It was then that India embarked upon a social forestry project with the aim of taking the pressure off the forests and making use of all unused and fallow land. Government forest areas that are close to human settlement and have been degraded over the years due to human activities needed to be afforested. Trees were to be planted in and around agricultural fields. Plantation of trees along railway lines and roadsides, and river and canal banks were carried out. They were planted in village common land, Government wasteland and Panchayat land.

Social forestry also aims at raising plantations by the common man so as to meet the growing demand for timber, fuel wood, fodder, etc, thereby reducing the pressure on the traditional forest area. This concept of village forests to meet the needs of the rural people is not new. It has existed through the centuries all over the country but it was now given a new character.

With the introduction of this scheme the government formally recognised the local communities' rights to forest resources, and is now encouraging rural participation in the management of natural resources. Through the social forestry scheme, the government has involved community participation, as part of a drive towards afforestation, and rehabilitating the degraded forest and common lands.

This definition of forest land reflects that law adopted by the Supreme Court of India in its judgment dated 12.12.1996⁵ in the Godavarman case. Clearly, the FRA is applicable to claimants in respect of forest lands wherever they may be located; no exception is made for municipal areas.

FRA only recognises pre-existing rights which are already being exercised by the eligible persons in the National Parks and Sanctuaries. History of the mandate

The UN General Assembly established The Office of the High Commissioner for Human Rights in December 1993 through its **resolution 48/141** which also details its mandate. This was just a few months after the World Conference on Human Rights adopted the **Vienna Declaration and Plan of Action**.

Adopted by 171 States, the Vienna Declaration renewed the world's commitment to human rights. It also called for strengthening and harmonizing the monitoring capacity of the United Nations system with regards to human rights.

The Universal Periodic Review (UPR) was created by the General Assembly in 2006 and is carried out by an inter-governmental working group of the Human Rights Council. The objective of the UPR is to review the fulfillment of the human rights commitments and obligations of all 193 UN member states as set out in: a) the UN Charter; b) the Universal Declaration of Human Rights; c) human rights instruments to which the State is party (human rights treaties ratified by the State concerned); d) voluntary pledges and commitments made by the State (e.g. national human rights policies and/or programmes implemented); and, e) applicable international humanitarian law. (It is a state-driven peer review mechanism, whereby all the UN member States are reviewed on the same terms.)

Pilot Project on QR Code-based Coin Vending Machine (QCVM)



As per the Coinage Act, 2011, the Government of India has the sole right to produce/mint coins including the ₹1 note. These coins are issued for circulation only through the Reserve Bank in terms of Section 38 of the RBI Act, 1934.

Presently, coins are largely distributed through the counters at all bank branches. Several measures have been undertaken recently such as enhanced incentives to banks for distribution of coins, use of mobile coin vans for coin distribution with a special focus on sub-urban, rural and remote areas along with holding of coin *melas* by currency chest branches.

To further improve distribution of coins by harnessing technology, the Reserve Bank has launched a pilot project on QCVM in collaboration with five banks (*viz.*, Axis Bank, Bank of Baroda, ICICI Bank, State Bank of India and Federal Bank).

The QCVM is a cashless coin dispensation system which allows payment transactions through UPI on scanning a dynamic QR code generated by the machine on the mobile phone of the customer.

Unlike cash-based traditional coin vending machines, the QCVM eliminates the need for physical tendering of banknotes and their subsequent authentication. Further, in QCVMs, the customers will have the option to withdraw coins in required quantity and denominations.

The pilot project is being initially rolled out at 19 locations in 12 cities across the country (*viz.*, Ahmedabad, Baroda, Bengaluru, Chennai, Hyderabad, Kanpur, Kolkata, Mumbai, New Delhi, Patna, Prayagraj and Kozhikode).

In India, state governments and agencies have different rehabilitation policies for the Jhuggi dwellers.

In Delhi, we have the Delhi Urban Shelter Improvement Board Act, 2010 (DUSIB Act, 2010) & Delhi Slum & JJ Rehabilitation and Relocation Policy, 2015 (RR Policy, 2015) which govern the Jhuggi rehabilitation.

The DUSIB Act,2010 & RR Policy, 2015 bars any eviction without proper rehabilitation. The procedure established by law also emphasizes in-situ rehabilitation unless the land was acquired for public purposes.

Till a few years ago Jhuggis in the capital had no protection against the arbitrary and unannounced demolitions by the agencies. To comply with the direction of the High Court, DUSIB formulated a Draft Protocol for the removal of Jhuggis and JJ Bastis in Delhi (hereinafter the draft protocol, 2016) in its 16th Board Meeting and notified the same on 14.06.2016.

Protocol to remove JJ Bastis:

- The DUSIB will be the **Nodal Agency** to conduct the **comprehensive surveys** and ascertain which of the JJ Bastis and Jhuggis would be entitled for in-situ improvement/development or re-settlement and rehabilitation.
- 2. It is essential that **a uniform approach** is adopted as regards all the jhuggis and JJ bastis in NCT of Delhi;
- 3. The removal of Jhuggis & JJ Bastis in Delhi will be as per the provisions of "Delhi Slum & JJ Rehabilitation & Relocation Policy, 2015 (Annexure A) as modified from time to time. The focus of the policy is on in-situ re-development and rehabilitation of Jhuggis and JJ Bastis as a matter of principle and relocation in exceptional cases.
- 4. This protocol shall be **followed by all agencies** including the Delhi Police in the event of any action for removal of Jhuggis and JJ Bastis in the future.



What is a "disturbed area" and who has the power to declare it?

A disturbed area is one which is declared by notification under **Section 3 of the AFSPA**. An area can be disturbed due to differences or disputes between members of different religious, racial, language or regional groups or castes or communities. **The Central Government, or the Governor of the State or administrator of the Union Territory** can declare the whole or part of the State or Union Territory as a disturbed area.
